



Ευρωπαϊκές Διαδρομές προς μια Διεθνική Αλληλεγγύη σε Καιρούς Κρίσης (TransSOL)

Σύντομη Περιγραφή

Το πρόγραμμα έχει στόχο να παρέχει τεκμηριωμένη γνώση σχετικά με το κοινωνικο-οικονομικό, πολιτικό και νομικό πλαίσιο της Ευρωπαϊκής αλληλεγγύης σε περιόδους οικονομικών κρίσεων σε οκτώ Ευρωπαϊκές χώρες (Γαλλία, Γερμανία, Ελλάδα, Ιταλία, Πολωνία, Δανία, Ελβετία και Ηνωμένο Βασίλειο). Παράλληλα στόχος του TransSOL είναι – μέσω της εφαρμογής ποσοτικών και ποιοτικών μεθόδων - να αναπτύξει ένα πολυδιάστατο σύνολο δεδομένων σχετικά με τις στάσεις και τις πρακτικές της αλληλεγγύης όπως αυτές εντοπίζονται και εκδηλώνονται σε επίπεδο μεμονωμένων πολιτών, οργανώσεων και μεταξύ των οργανωτικών πεδίων, καθώς και στα μέσα μαζικής ενημέρωσης και τη δημόσια σφαίρα. Αντό το σύνθετο σύνολο δεδομένων θα επιτρέψει την καλύτερη κατανόηση της εσωτερικής λογικής, των προσδιοριστικών παραγόντων και της εγγενούς δυναμικής της αλληλεγγύης και, ειδικότερα, την επίδραση της κρίσης στα διάφορα επίπεδα της αλληλεγγύης.
